

Invitation For Bids

2. Though the gross calorific value mentioned below is minimum 5700 Kcal / Kg. Coal of higher calorific value can be supplied without extra claim and Moisture Content mentioned is 5% Maximum. Coal having moisture upto 12% can be supplied for which excess moisture more than 5% to 12% shall be deducted from actual weight. Moisture higher than 12% shall be rejected .
