

Invitation for Bids

1. **Udayapur Cement Industries Ltd.** re-invites sealed bids from eligible bidders for the procurement of **Design, Engineering, Erection and Performance Supervision, and Consultancy for 3 month after erection of RSP System UP-Grading (Package-B)** at Plant site, Jaljale, Udayapur.
2. Eligible bidders may obtain further information and inspect the bidding documents at the head office of Udayapur Cement Industries Ltd., Jaljale Udayapur. Telephone No. 035-411012, Email: procurement@ucil.org.np.
3. Bidding documents may be purchased from the above 13:00 PM on **2020/ 07/12 (2077/03/28)** office of Udayapur Cement Industries Ltd. by eligible bidders on the submission of a written application along with the Notarized copy of firm registration, VAT certificate and Tax clearance certificate of F/Y 2075/76 from Notary Public office and upon payment of a non-refundable fee of NRs. **5000.00 (Five Thousands) only**. Or, the bidder who wishes to bid through electronically or e-bidding shall visit the website <http://www.ucil.org.np> > eprocurement system and may download bidding document and submit them.
4. Three sets of sealed Bid documents (One original + Two copies) as per ITB 22.1 must be submitted to the office of Udayapur Cement Industries Ltd., Jaljale, Udayapur as below: on or before 14:00 PM on **2020/ 07/12 (2077/03/28)**. Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend on 15:00 PM on **2020/ 07/12 (2077/03/28)**) at the office of Udayapur Cement Industries Ltd., Jaljale, Udayapur. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5% for Nepalese bidders and 5% for foreign bidders, of the quoted Bid amount (exclusive of VAT)** valid up to days from the date of bid opening. (i.e **120 days 2020/ 07/12 (2077/03/28)**).
6. If bidder wishes to submit the Cash Security, the cash shall be deposited in Current Account No. of Sunrise Bank Ltd., Udayapur Branch, Jaljale, Udayapur: 0290096430701002 or in any convertible currency in the form of bank draft in favor of UCIL and submit the receipt of the deposited amount of cash along with the tender document.
7. If the last dates of purchase, submission and opening fall on UCIL holidays, then the next working day shall be considered as the last day without any change in time and place. In such a case, the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

Introduction

UDAYAPUR CEMENT INDUSTRIES LIMITED is established 25 years back with an installed capacity of 800 TPD Clinkerization and 1000 TPD Cement Grinding. The total machinery was supplied by Kawasaki Engineering, Japan. The Plant is located of Jaljale, Udayapur, NEPAL. The distance from Bagdogra to Plant is around 300 KMs by Road. The distance from Kathmandu to the plant is around 350 KMs.

Presently the plant is operating in the range of 600 to 700 TPD clinker per day consuming around 75 units per tonne of clinker and coal consumption of around 1250 K. Cal per tonne of clinker. With this operating conditions, the plant is not able to make any positive contribution. Hence, the management of UDAYAPUR CEMENT INDUSTRIES LIMITED took a decision to enhance the present plant capacity from 700 to 1100 Tonnes per day to reduce Coal and Power consumption.

Detail Scope of Work.

1. Group A.

1. Preparation of Refractory / castable drawings including size, quantity and quality.
2. Preparation of drive list for the modified circuit to float enquiries for the MCC Panels.
3. Preparation of Tender documents for up gradation of plant capacity either as a package or individual equipments.

2. Group B.

1. Submission of Minimum 3 Vendors for each equipment / package for floating enquiries.
2. Collection of existing plant data such as capacities of each equipment, operating efficiencies for complete pyro section starting from Blending silo to Coal Dozing system.
3. Compiling the data and to work out the capacities required for 1100 TPD including installation of new burner, Static cooler, Kiln Feed and Coal Dozing Systems etc.,
4. Working out of all pollution control equipments and preparing the specifications for up gradation wherever required.

3. Group C.

1. To study the existing kiln drive ratings including gear box sizing and suggest necessary modifications if required to increase the RPM from present 1.8 RPM to 3 RPM.
2. Study of existing cooler exhaust collection system and suggesting suitable modifications for improving the collection efficiency.
