4. Three sets of sealed Bid documents (One original + Two copies) as per ITB 22.1 must be submitted to the office of Udayapur Cement Industries Ltd., Jaljale, Udayapur as below: on or before 14:00 PM on **2020/01/29 (2076/10/15)** Documents received after this deadline shall not be accepted.
